## Camp Brilliance is focused on art, activism, coalition building, and celebrating youth brilliance.

Over the course of the week, camp attendees will develop a social action project, learn about ways to make a positive change in their community, and get messy making art. **Camp Brilliance** will be led by Hardy Girls staff, members of our Feminist Action Board (FAB), and trained adult volunteers.

**Who it's for:** Camp Brilliance is open to girls and gender-expansive youth entering grades 5-8 in Central Maine\*, and it is free of charge to all attendees.

**When and where:** Camp Brilliance will be held Monday July 18 through Friday July 22, from 9 am to 3 pm daily. This year's camp location is Greene Block + Studios in downtown Waterville, Maine.

**Food and beverage:** Hardy Girls will provide water and snacks daily and attendees will need to bring a lunch on Monday-Thursday. Hardy Girls will provide a celebratory lunch on Friday.

## Hardy Girls is excited to partner with incredible, local artist educators during Camp Brilliance.

**Elizabeth A. Jabar** is a feminist printmaker who explores a range of personal-political issues in her work including cultural identity, representation, equity and maternal ethics. Her practice is located in the studio, the classroom and the community where she co-creates collaborative and participatory projects with students, colleagues and community members. Her hybrid works on paper and cloth display a highly personal visual language that incorporates motifs from popular culture, folk art, religious traditions, and textiles. Elizabeth's printed objects and environments embody printmaking's democratic tradition of resistance and collective power and reflect her commitment to art as a tool for social change.

**Evelyn Wong** is an interdisciplinary artist exploring themes of history, trauma, culture, race, and gender through the lens of personal narratives as well as her Asian American heritage. She has recently exhibited work at the Northern Arizona University Art Museum in Flagstaff, Arizona, the Portland Museum of Art in Portland, Maine, and the Museum of Craft and Design in San Francisco, California.

**Colleen Kinsella** is a printmaker and musician born in 1975 in White Plains, NY. She currently lives and works in Portland, Maine. She graduated in 1997 from Syracuse University with a BFA in Photography and Printmaking. Kinsella has been a studio technician and instructor in the Printmaking Department at Maine College of Art since 2000. She will be teaching at USM's Stone House Book Arts Program in the summer of 2014.
